## 2015 PIONEER BANDS POPCORN SALE

## OUR GOAL IS TO RAISE \$12,500 FOR THE PIONEER BANDS

Based on feedback from many parents, instead of candy, this year we are going to be selling popcorn from Poppin Popcorn, a company based in Holland, Michigan. The popcorn comes in a printed box with a carrying handle. There are 10 Half-Gallon bags of popcorn in each box: 5 each of Caramel Corn and Chicago Style (caramel corn and cheddar corn). Individual bags sell for \$10.00 each; students and parents are not allowed to sell the product for any other price. \$100 must be turned in for each box taken.

Students participating in this fundraiser will sell ONE box, and will receive a family fundraising credit of \$50 per box sold. Since we cannot return boxes, students and parents are responsible for any and all popcorn they take, whether it is sold or not..

YOU MAY NOT SELL DURING REGULAR SCHOOL HOURS (BEFORE OR AFTER SCHOOL IS ACCEPTABLE).

THEFT OF POPCORN AND MONEY FROM CLASSROOMS, SCHOOL LOCKERS, BACKPACKS AND AUTOMOBILES IS A REAL POSSIBILITY THAT MUST BE ADDRESSED BY THE STUDENTS AND PARENTS BY EXERCISING DUE DILIGENCE AND PERSONAL RESPONSIBILITY.

Popcorn will be delivered outside the band room after 6th hour on Tuesday, September 22. Please plan to pick up your popcorn at that time.

Money from the sale is due on or before Tuesday, October 13. FOR SECURITY, PLEASE SEND THE AMOUNT DUE IN ONE CHECK MADE PAYABLE TO THE PBA. Please put your STUDENT'S NAME, BAND, AND POPCORN SALE in the memo line. Popcorn Sale Money should be turned in to the band office drop box using the PBA money envelope provided to each student.
