# **Secretary's Report**

This year PBA held a mandatory general meeting on September 9<sup>th</sup> for all band parents. The meeting was well attended and proved an efficient way of transmitting information and answering questions at the start of the year. Subsequent PBA general meetings were held on the 2<sup>nd</sup> Tuesday of the month at

7:30 p.m. in the Pioneer band room. Attendance at the regular monthly meetings averaged about 18 parents a meeting. David Leach and Nancy Waring shared information about our bands and there was much lively discussion about PBA activities. The purchase of new equipment for the drum line and the funding of a bookkeeper position for the PBA were two important decisions discussed and voted on this year. Minutes of the meetings are available at our band website: www.aapioneerbands.org. The PBA Annual meeting will be held on the third Tuesday of April this year, due to spring break. Next year's board will be voted in during this meeting.

In addition to the general meetings, the executive board met on a monthly basis during the school year to discuss PBA business and to set agenda items for the general meetings.

Thanks to the involvement of hundreds of parents, the PBA continues to be an active community of parents working together to support our children and the Pioneer Bands.

## **Treasurer's Report**

The PBA fiscal year runs from July through June. Two significant events occurred during the 2007 fiscal year after the April 2008 Treasurer's Report was published. Picnic Pops took place in May 2008. The revenue from Picnic Pops was \$6,295. However, after expenses, Picnic Pops suffered a net loss of \$602. Band Camp took place in August 2008, although the fees for tuition and transportation were paid in the 2007 fiscal year. The cost of the 2008 Band Camp was \$53,675. This amount does not include several full and partial scholarships that were awarded by the PBA to qualified students who attended the camp.

The fiscal year beginning cash balance on July 1, 2008 was \$81,906. To date, \$6,880 has been collected from PBA families for the \$25 program fee. Other funds raised during the year (net of expenses) were: Direct Contributions - \$6,233, Candy Sales - \$8,508, Car Wash -\$3,240, Concessions at the District Band Festival - \$1,150, and the Band Gala - \$15,251. During the year, expenditures included: Contribution for New Percussion Equipment for Symphony Band Drum Line - \$5,525, Sectional Instruction - \$2,649, Guest Instructor - \$500, and the Bowling Party (January 2009) - \$806. As of March 31, 2009, the cash balance was \$62,747. The Albritton Endowment Fund, managed by the Ann Arbor Area Community Foundation, currently has a balance of \$15,162.

At this time I would like to thank Bart Polot for his service as last year's PBA Treasurer, Jill Polich for all her work as PBA Treasurer earlier this year, and Daryl Hurst, the PBA Bookkeeper, for his tireless efforts in maintaining the PBA accounting records, depositing the receipts, paying the bills, filing the tax return, and setting up the individual student accounts.
